**Acceptance of the Terms of Use.** These terms of use are entered into by and between you and, as applicable, CCB Financial Corporation, Country Club Bank, Country Club Trust Company, Country Club Bank - Capital Markets Group, Asset Management Group, Inc., Wheatland Advisors and The Capital Corporation (individually and collectively, **"Company," "we," or "us"**).
