Deal Activity \& Valuations

## Deal Activity

Mergers and acquisitions activity through the end of the second quarter of 2020 fell $17 \%$ on a year-over-year basis as the continued economic effects of the coronavirus pandemic drastically impact deal activity in the United States. Additionally, total deal value continues to decline as acquirers have developed a more cautious approach to the deployment of capital, given the vast uncertainties surrounding the pandemic.

## Valuations

Valuation multiples remained flat for Q2 2020 in comparison to Q1 2020. After reaching a high of $10.9 x$ in 2019, the median Enterprise Value (EV) to EBITDA multiple declined by one full turn to $9.9 x$ in 2020. While this still represents a high level by historical standards - a 34\% increase compared to 2009 - valuation multiples may contract further for the remainder of 2020 given frequent fluctuations as presented in the stock market.
