

Website Terms of Use

Acceptance of the Terms of Use. These terms of use are entered into by and between you and, as applicable, Country Club Bank, Country Club Trust Company, Tower Wealth Managers, Country Club Financial Services Inc., Country Club Bank - Capital Markets Group, Asset Management Group Inc., Wheatland Advisors, CC Capital Advisors, and The Capital Corporation, (individually and collectively, "**Company**," "**we**," or "**us**").
